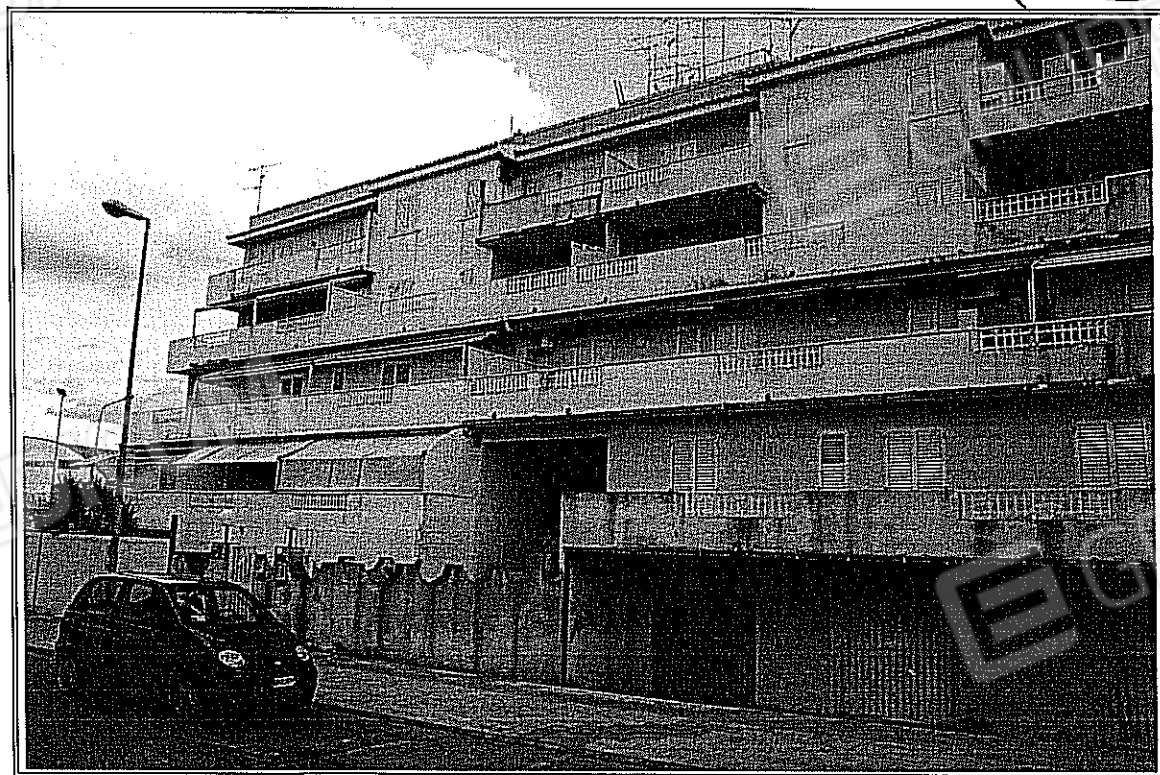

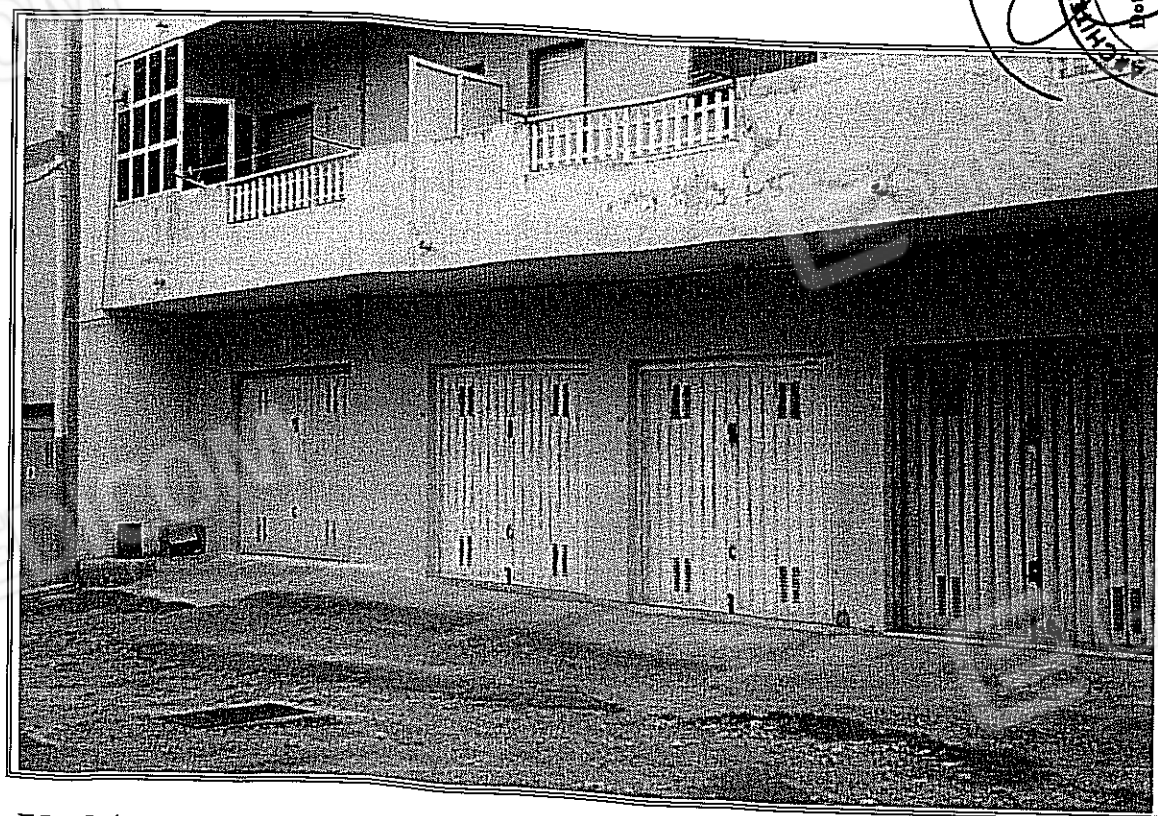


FOTO 4 – Prospetto interno – box garage

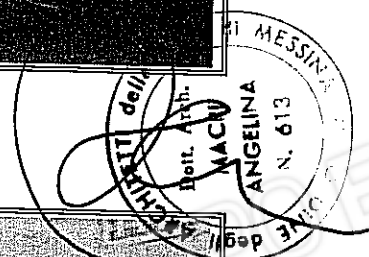

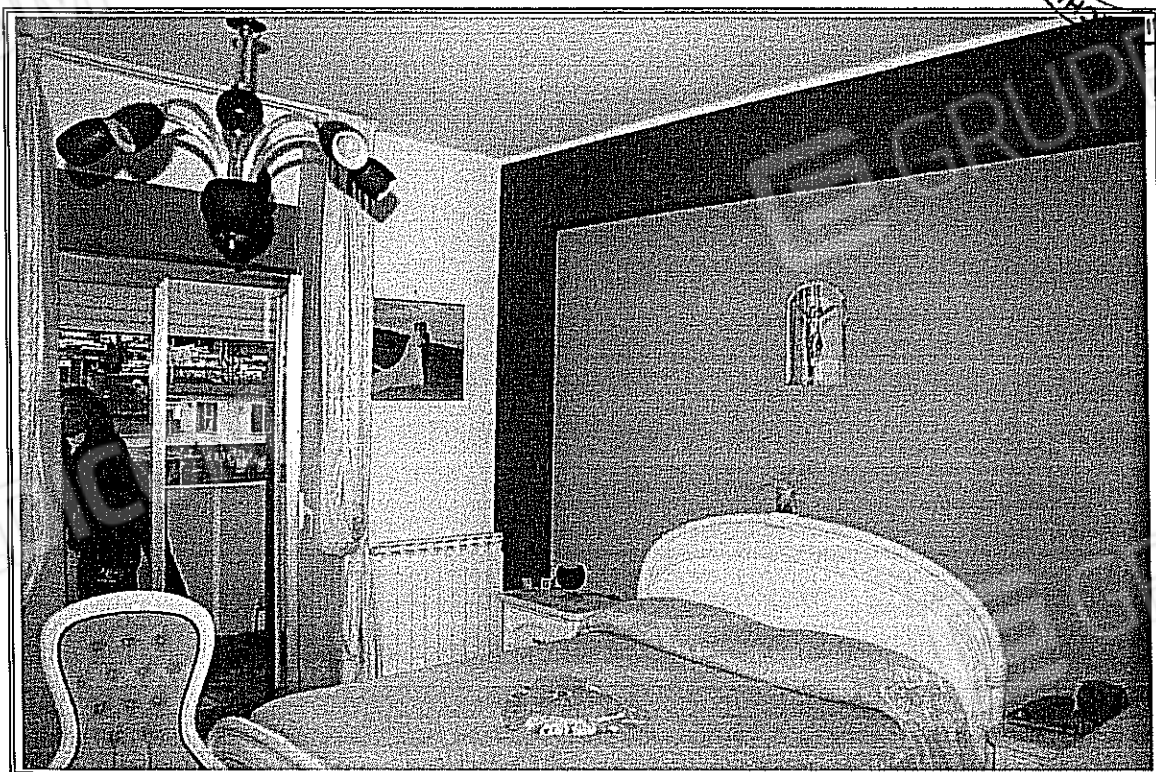

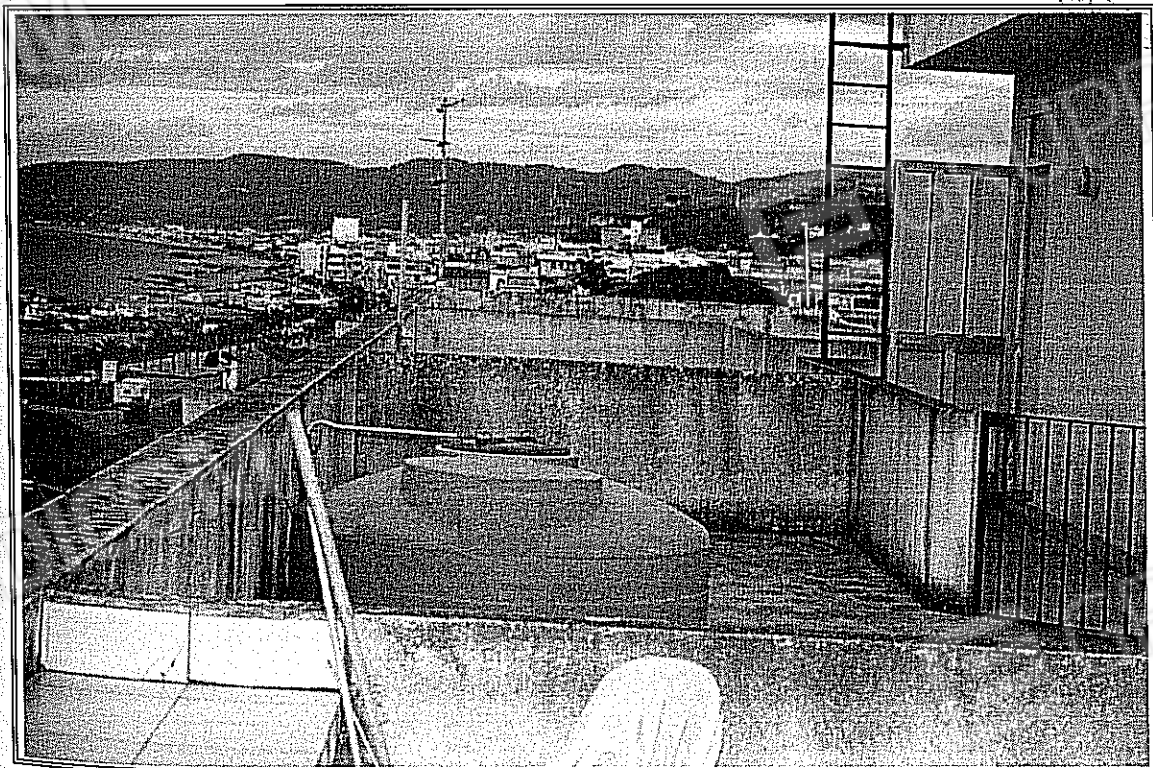
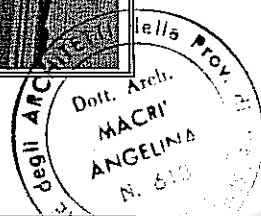


FOTO 8 - F. 2 part. 1358 - 1476 sub 30 - Lastrico solare piano quarto

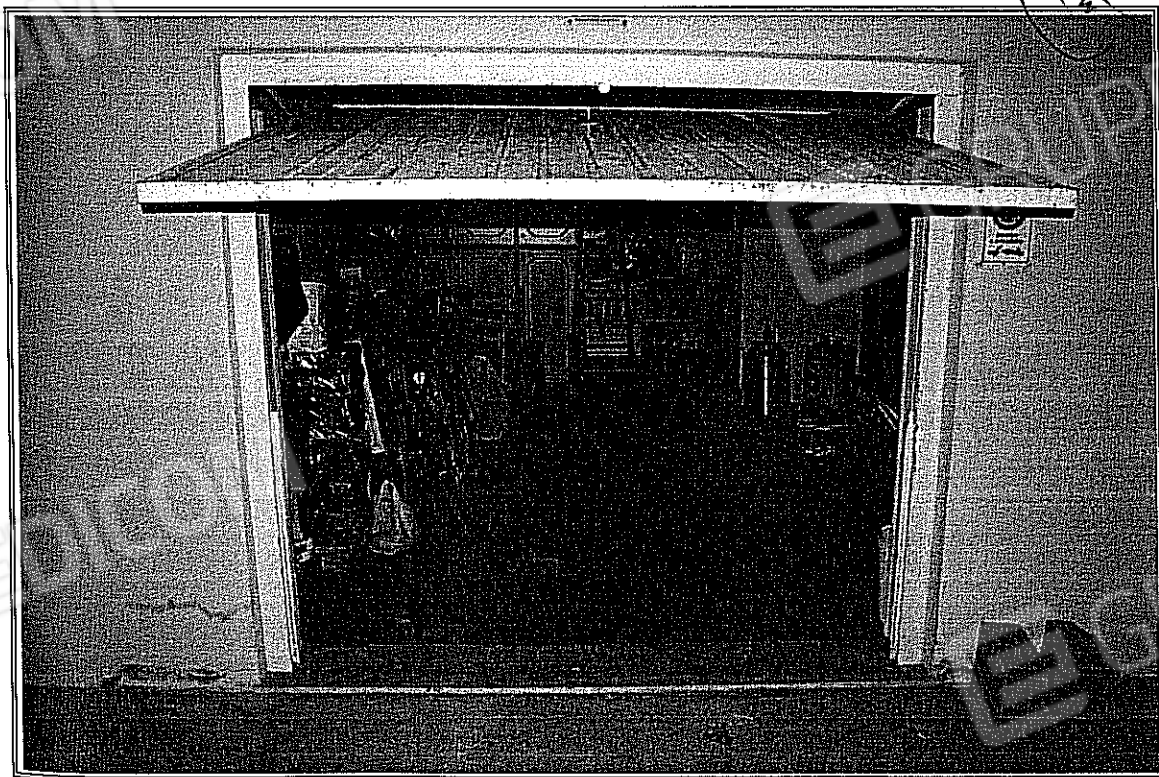
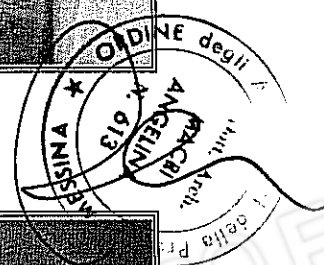


FOTO 14 – F. 2 part. 1358 – 1476 sub 7 - Box

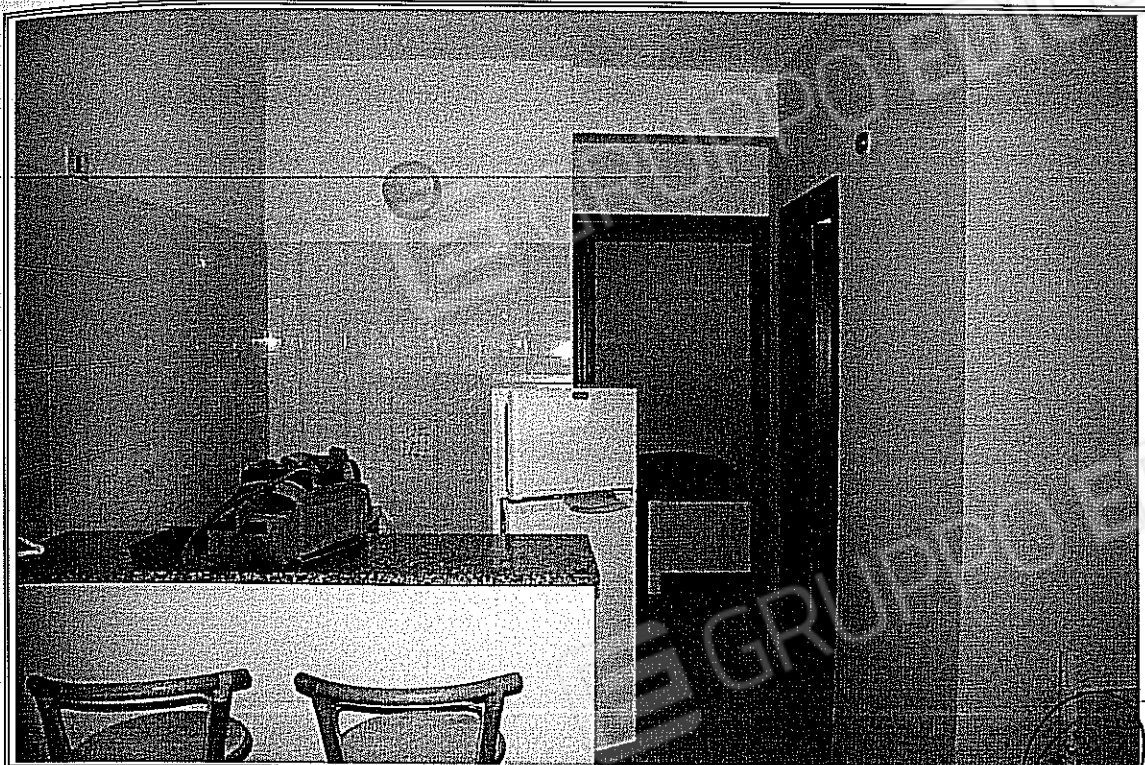


FOTO 15 – F. 2 part. 1358 – 1476 sub 23 - Alloggio piano terzo

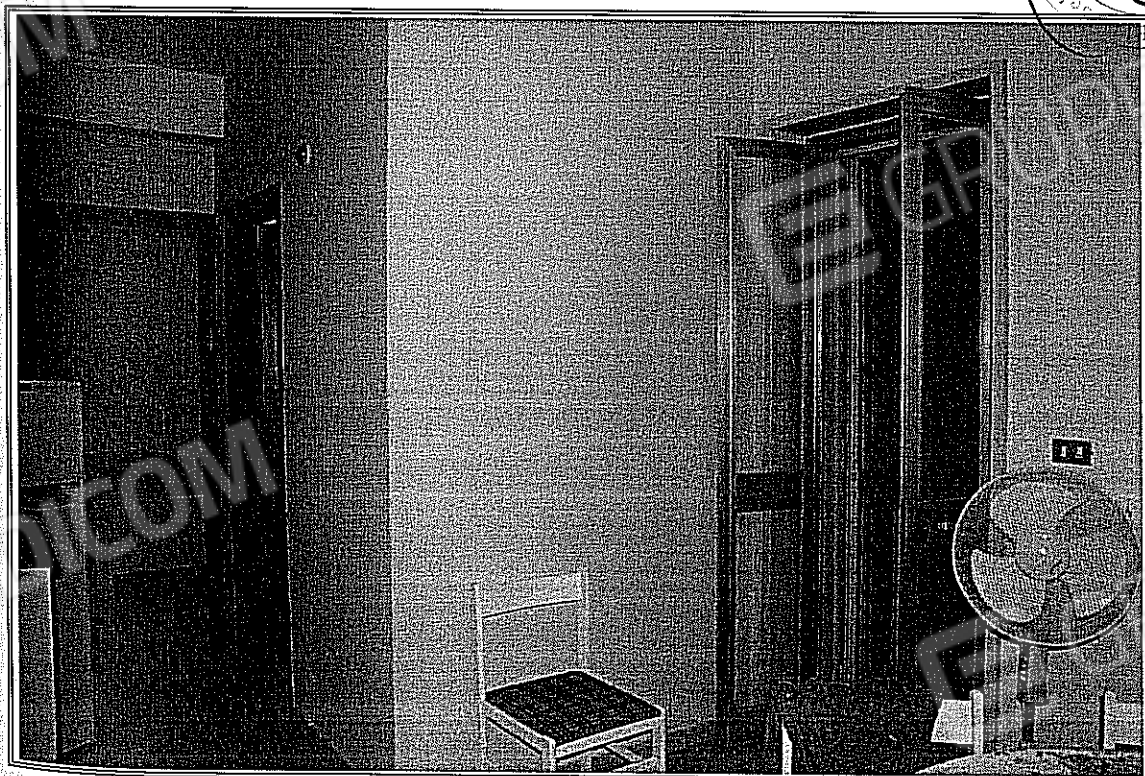

FOTO 19 – F. 2 part. 1358 – 1476 sub 6 - Box

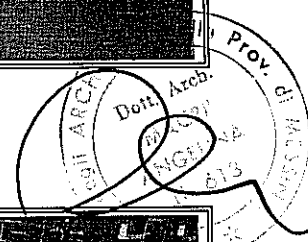


FOTO 20 – F. 2 part. 1358 – 1476 sub 29 – Lastrico solare piano quarto

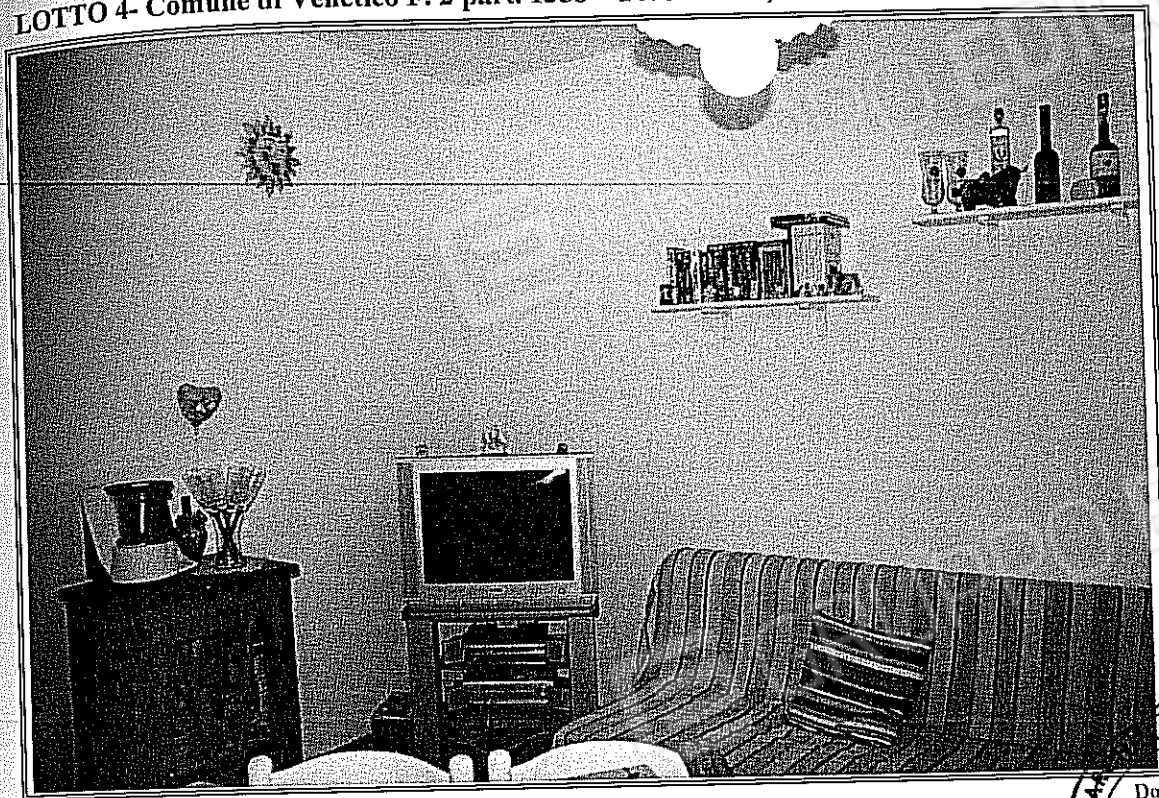


FOTO 21 – F. 2 part. 1358 – 1476 sub 22 - Alloggio piano terzo

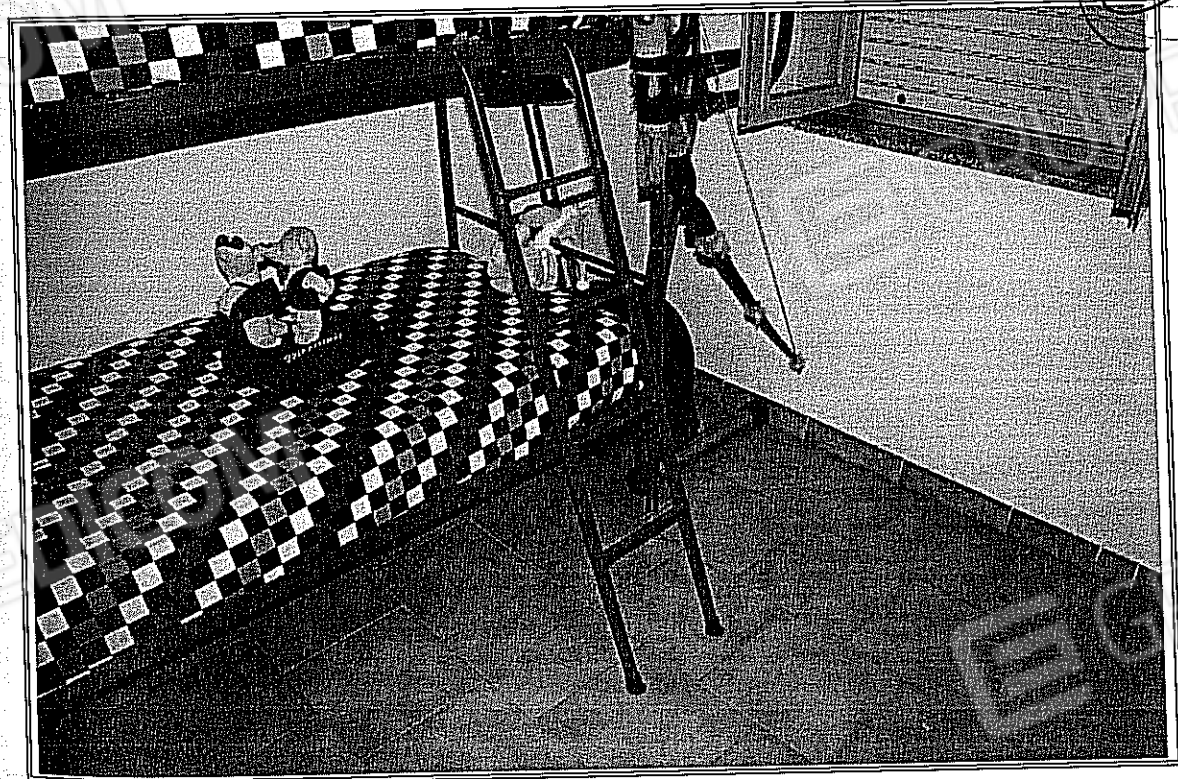

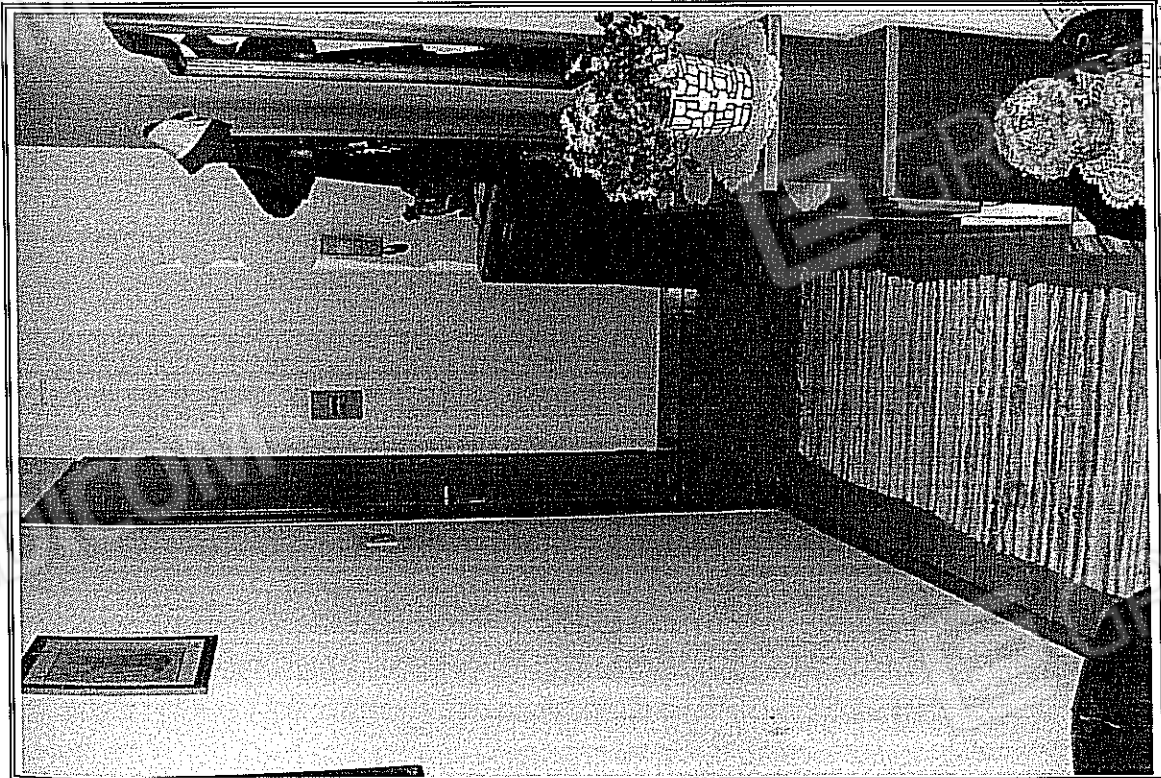

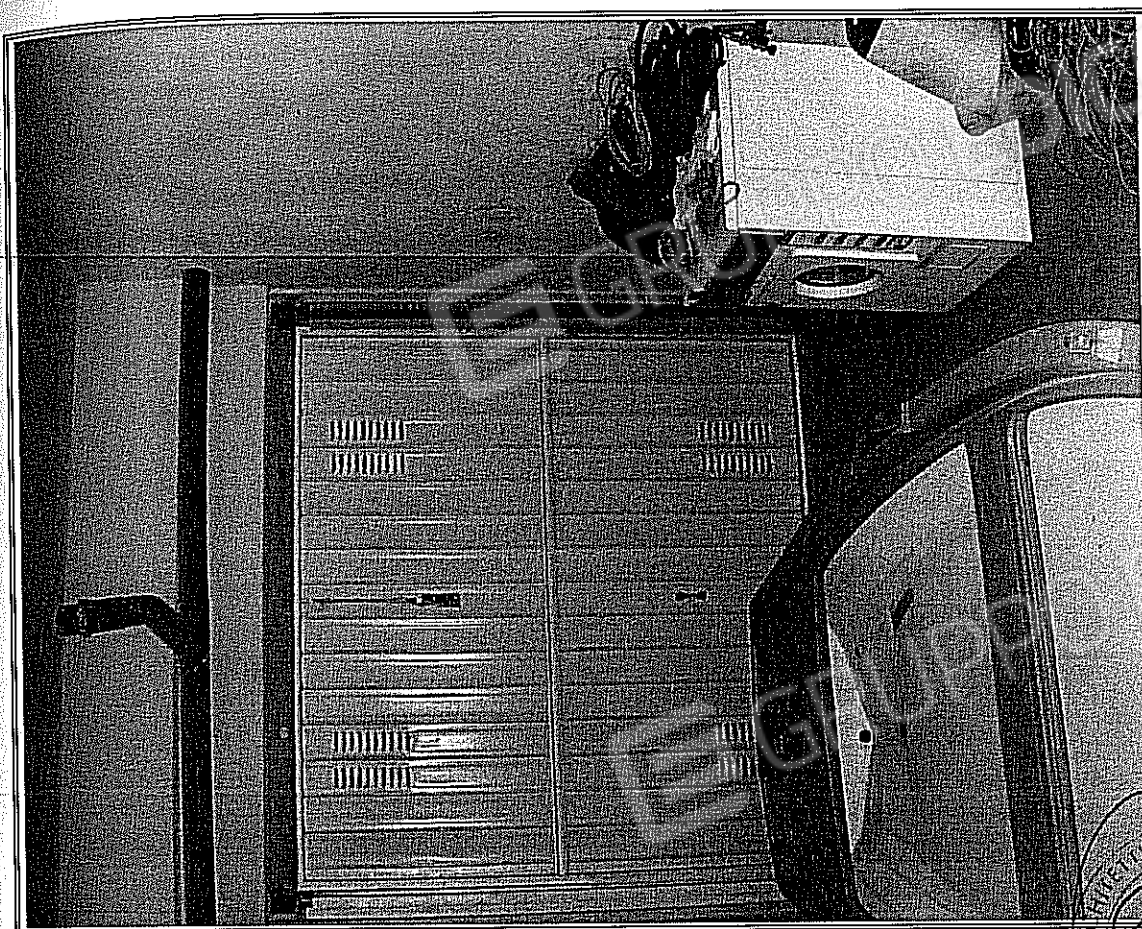


FOTO 31 – F. 2 part. 1358 – 1476 sub 4 – Box

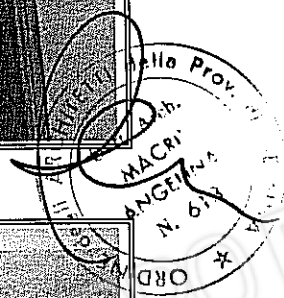


FOTO 32 – F. 2 part. 1358 – 1476 sub 4 – Box

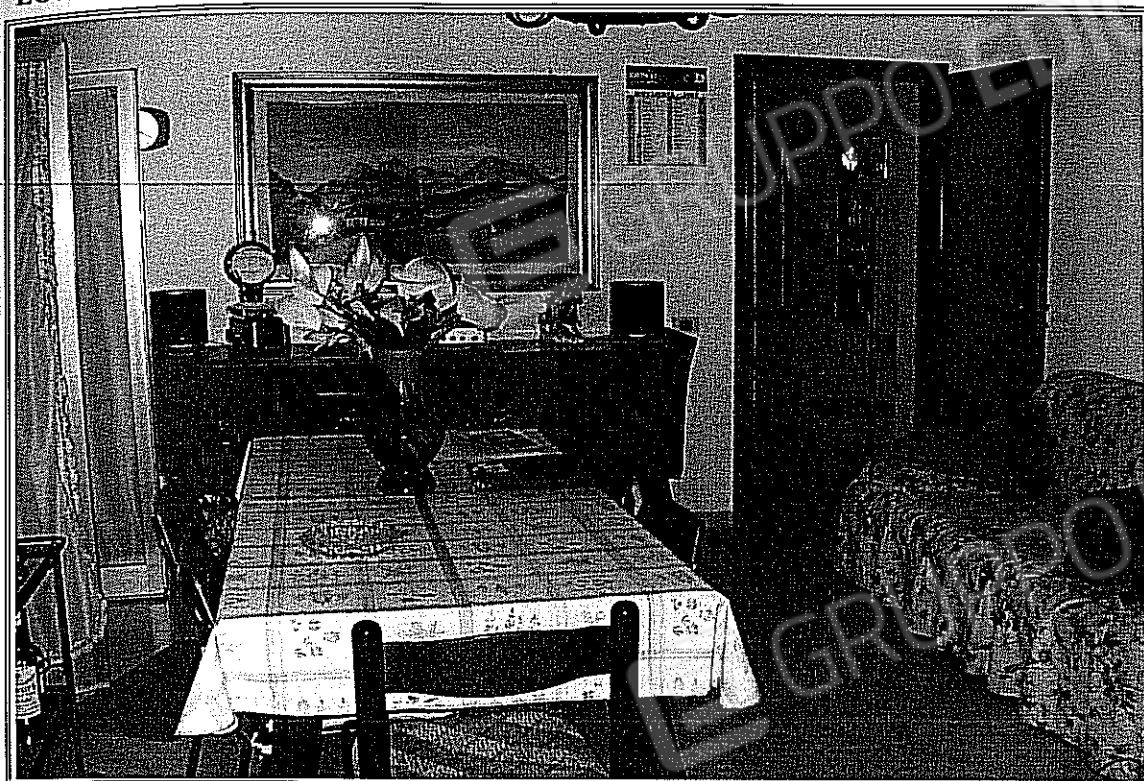


FOTO 33 – F. 2 part. 1358 – 1476 sub 17 - Alloggio piano secondo

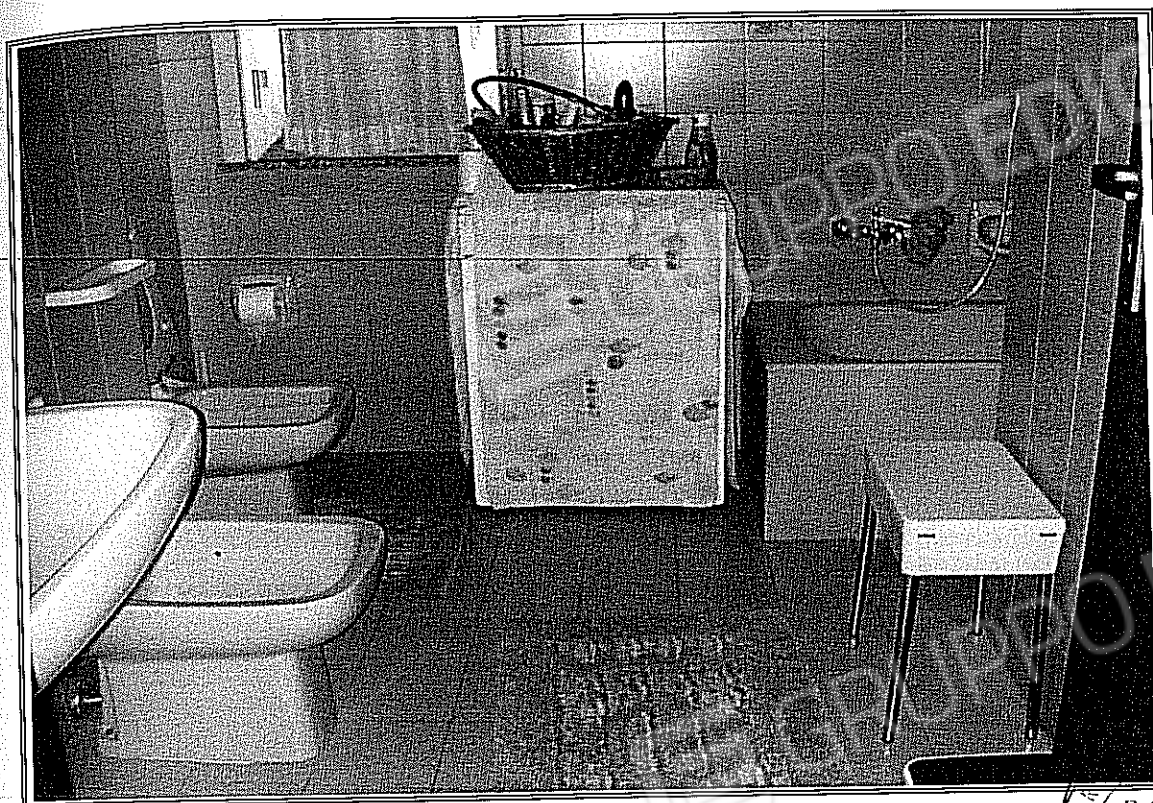

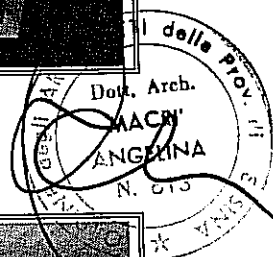

LOTTO 8- Comune di Venetico F. 2 part. 1358 – 1476 sub 20

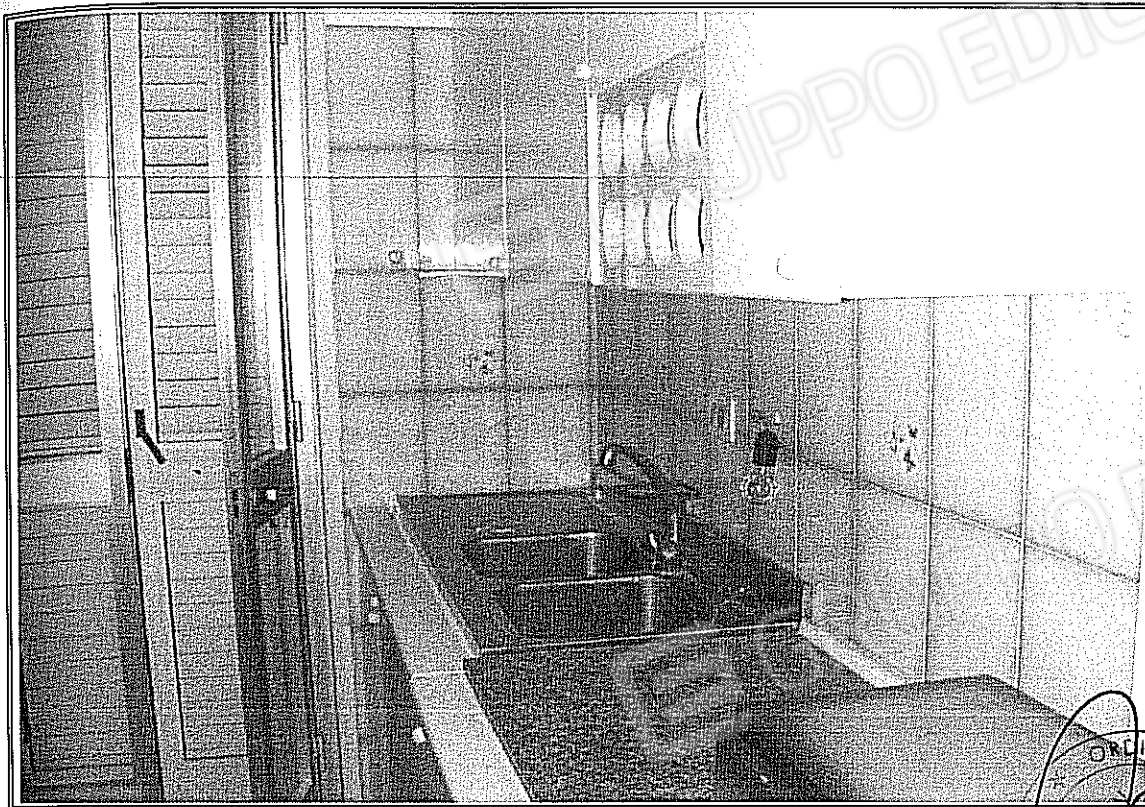


FOTO 43 - Alloggio piano secondo
